Rules and Guidelines for Pool Opening

The danger of exposure to the Corona Virus that causes COVID-19 still exists. By entering the pool, you take full responsibility for your own protection and for disinfecting your hands and anything you touch in the pool/pavilion area. POA does not assume liability for injury or illness relating to pool use.

New pool hours will be from **8:00 AM to 9:00 PM.**

The following Rules for Pool Use are in effect and anyone using the pool must agree to follow these rules:

- It is likely that the area most at risk for contagion is the restroom.
- While use is at your own risk, it is encouraged that restroom use be kept to a minimum.
- If you see that the pool has been contaminated by fecal material or other bodily fluids, please notify the GWW administrator at once.
- Please limit pool time to 1.5 hours so other neighbors get to enjoy the amenity
- A maximum of 10 people can be in the water (or one family unit). If there are more than 6 in the family, then only 4 more family members may join to equal 10). Only a total of 20 people is allowed in the pool and the pavilion area.
- Use of existing pool furniture is allowed; however, you are advised to wipe any furniture prior to use. For greater safety, you are encouraged to bring your own chairs and tables.
- Use of pool toys is discouraged.
- The water fountain will be closed, so bring your own water.

Thank you for understanding and please be courteous to your neighbors and share in the amenities.
